Customer Charge: \$278.99 per delivery point

Demand Charge: \$12.11 per kW per month of the customer's onpeak billing demand, plus \$2.28 per month for each kW, if any, of the amount by which the customer's offpeak billing demand exceeds its onpeak billing demand, plus an additional

\$12.11 per kW per month for each kW, if any of the amount by which (1) the customer's onpeak billing demand exceeds the higher of 2,500 kW or its onpeak contract demand, or (2) the customer's off peak billing demand exceeds the higher of 2,500 kW or its offpeak contract demand, whichever is higher.

Energy Charge: 7.203¢ per kWh per month for all onpeak kWh, plus 6.118¢ per kWh per month for all offpeak kWh.

\$12.11 per kW per month for each kW, if any of the amount by which (1) the customer's onpeak billing demand exceeds the higher of 2,500 kW or its onpeak contract demand, or (2) the customer's off peak billing demand exceeds the higher of 2,500 kW or its offpeak contract demand, whichever is higher.

Energy Charge: 7.203¢ per kWh per month for all onpeak kWh, plus 6.118¢ per kWh per month for all offpeak kWh.

\$12.11 per kW per month for each kW, if any of the amount by which (1) the customer's onpeak billing demand exceeds the higher of 2,500 kW or its onpeak contract demand, or (2) the customer's off peak billing demand exceeds the higher of 2,500 kW or its offpeak contract demand, whichever is higher.

Energy Charge: 7.203¢ per kWh per month for all onpeak kWh, plus 6.118¢ per kWh per month for all offpeak kWh.
