### Seasonal Demand and Energy Service

#### Residential Rate Class (122CON)

**Customer Charge:** \$15.36 per month

Less Hydro Credit \$1.60

**Energy Charge:** 9.737¢ per kWh

#### General Power Rate Class (140 CON)

**Customer Charge:** \$29.53 per delivery point

**Energy Charge:** 10.714¢ for all kWh

#### General Power Rate Class (150 CON)

##### (GSA-2)

(51 kW to 1,000 kW)

**Customer Charge:** \$98.44 per delivery point

**Demand Charge:** First 50 kW - no charge.

Excess over 50 kW billed: \$14.07 per kW

**Energy Charge:** 10.967¢ 1st 15,000 kWh

**Customer Charge:** \$295.30 per month

**Demand Charge:** First 1,000 kW of billing demand at \$12.34 per kW,

Excess over 1,000 kW of billing demand per month at \$11.54 per kW,

Plus an additional \$11.54 per kW per month for each, if any, of the amount by which the Customer's billing demand exceeds the higher of 2,500 kW or its contract demand

**Energy Charge:** 6.678¢ per kWh per month
